Eligibility

To be eligible for itison us, your charity must:

- Be registered as a charitable organisation exclusively in Scotland or England & Wales.
- Charities must be non-profit or non-governmental organisations with recognised charitable status.

Responsibility

All charities selected by itison us must agree to:

- Use and distribute vouchers responsibly, and in accordance with our terms.
- Have a plan of how to use the vouchers. Vouchers will be valid for a few weeks or months, so it's important you're able to use them during this timeframe.
- Report back on exactly how the vouchers were used, and any funds raised as a result.
